The Principal instructs the Trustee to sign on behalf of the Principal **Competition  
participant form**, certifying with a signature that the Principal is familiar with the terms of the relevant  
Offer Agreement and the Race Regulations posted on the Competition website, and accepted their terms  
unconditionally and in full, and also that the Principal gives his

informed and conscious consent to the processing of your personal data, including the cross-border transfer of personal data, including the processing of personal data by other persons on behalf of the Event Organizer: LLC "RUNNING HISTORY" OGRN 1235000113039, INN 503 2366511 limited liability company "Chronotrek" Systems Europe B.V." Address: Zuidergracht 21-21, 3763 LS, Soost, The Netherlands; freely, of your own free will and in your own interest, on the terms presented in section 6 "Personal data of a race participant and informed consent to their processing by a race participant" of the relevant offer agreement, in particular: processing of personal data, including collection, recording, systematization, accumulation, storage, clarification (updating, changing), retrieval, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

The processing of the Principal's personal data is carried out solely for the purposes of registration of the Principal for the Competition, calculation of the time the Principal will cover the entire distance and intermediate cutoffs (if any), for the purpose of publishing the calculation results in the following publicly available sources: on the Competition page on websites determined by the Organizer at its discretion, and/or in mobile applications determined by the Organizer at its discretion, and subsequent sending to the Principal email messages and SMS notifications containing information about the Competition and any other information relating to the Principal and related to the Competition.

The Principal agrees to the processing of the following personal data as a participant in the Competition: full name, gender, date of birth, country and city of residence, Participant number, Participant tag number, contact phone number, contact e-mail, time of reading the Participant tag from using special equipment, the distance chosen by the Participant, the start time chosen by the Participant.

Consent to the processing of personal data is valid for 20 years from the date of transfer of personal data; consent can be withdrawn in writing by sending a registered letter to the Event Organizer.

The Principal instructs the Trustee to certify with his signature on behalf of the Principal the fact that the Principal confirms that he is in proper physical shape and regularly undergoes medical examinations in order to ensure the safety of participation in the race for his health, in accordance with Part 5 of Art. 24 Federal Law of December 4, 2007 329 Federal Law "On Physical culture and sports in the Russian Federation", does not have any medical or other health restrictions that could jeopardize or limit his participation in the race, including no contraindications to prolonged physical activity and his state of health allows him to participate in the race, and assumes all risks and negative consequences associated with violation of this condition.

In confirmation of this condition regarding the state of health, the Principal instructs the Trustee to provide the Organizer with a medical certificate issued based on the results of a medical examination of the state of health. In this case, the Principal assumes full responsibility for the authenticity of the medical certificate, its receipt in accordance with the procedure established by law on the basis of a medical examination and in an authorized medical institution, as authorized by the Trustee
